Hull Community Walking Track and Turf Field Timeline

2015

- September 28 Advisory Board voted 6 1 for No Action on citizen's petition turf article.
- October 6 Board of Selectmen voted 5 0 to support the Hull Community Walking Track and Turf Field STM article, so long as funding was contingent on passage of a debt exclusion in the spring of 2016. The BoS also approved the expenditure of up to \$100,000 for project design and planning immediately if the STM warrant article was passed.
- October 7 School Committee voted 3 1 to support the Hull Community Walking Track and Turf Field STM article, with new language that ties it to funding from the debt exclusion. The School Committee also voted 3 to 1 to accept the project should it pass STM.
- October 15 Special Town Meeting voted to approve Article 6. The original vote failed with 290 in favor and 180 against (61.7% in favor, failing to reach required 2/3 supermajority). Upon a successful motion to reconsider, Article 6 passed with 153 in favor and 39 against (79.7% in favor). It should be noted that although 631 registered voters checked in at STM, only 470 participated in the first vote on Article 6.
- October 19 School Committee discussed the events of STM and requested Matt Gillis to draft an RF for design services.
- November 2 ECH reiterates that SC will consider grass <u>and</u> synthetic turf options, as well as synthetic infill options as part of the design process. School Committee voted (3 to 0) to issue RFP for Design and Construction Oversight of Hull Community Walking Track and Turf Field Project.
- November 10 Site visit for prospective RFP bidders
- November 18 ECH received letter from Advisory Board requesting that SC postpone awarding RFP until after vote on Debt Exclusion.
- November 24 Deadline to submit proposal in response to RFP.
- December 7 Members of the Advisory Board, the School Committee and the public discussed the merits of proceeding with project design before passage of the debt exclusion. The SC unanimously agreed that the more information gathered in advance of the Town Meeting the better informed the community would be. The SC agreed that something has to be done about the field because it is a danger and this process will help in the future no matter what the vote is on the debt exclusion. The School Committee then opened proposals from three bidders: Stantec, Huntress and Gale Associates. The SC scored each of the three proposals based upon a criteria developed by Matt Gillis. The SC voted 5 to 0 to invite each of the three bidders for an interview.
- December 14 (1) School Committee separately interviewed Stantec and Gale Associates. Each bidder made a presentation and answered predetermined questions developed by Mr. Gillis and SC members. At the conclusion, the SC finished scoring the remaining bidders' proposals. (Huntress dropped out) Gale Associates was ranked highest. The SC then opened the price proposals. Gale Associates was the low bidder. The SC then voted 5 to 0 to enter into contract negotiations with Gale Associates for design and construction oversight services. The SC specifically requests that the contract allow the SC to stop the project at any time without penalty.

December 23 Project Startup meeting with Gale Associates. "Turf Project Working Group" made up of ECH, Dr. Tyrell, Matt Gillis, Diane Saniuk, and Jim Quatromoni Reviewed project schedule, project budget, project components and immediate work plan. Discussed initial cost estimate and first revision. Discussed project timeline: PHASE 1 – site investigation, geotechnical/soils evaluations, utilities investigation, wetlands delineation/habitat evaluation/flood plain evaluation, and topographic survey. PHASE 2 – design program development, schematic design and preliminary cost estimate. Discussed community outreach required for program development. At end of Phase 2, SC would need to make a decision on grass vs. synthetic turf. PHASE 3 – Construction Plan Development, Technical Specifications and Project Manual, Design Development Project Team Meetings. PHASE 4 – Permitting. PHASE 5 – Bid, Award and Construction Period Assistance. Project Close out.

2016

- (3) January 21, $2016 1^{st}$ cost estimate based upon site investigation work.
- (4) February 3, 2016 removed dugouts/added benches for baseball/softball (-\$45k Δ); reduce entranceway improvements from \$50k to \$5k; minor adjustment to track; adjust bond & insurance.
