1.0 Call to Order

9.1 Sub-committees

- MSBA met on January 16, 2020 and discussed a new schedule that MSBA wants us to follow. Mr. DeGennaro stated that the \$46,000 that was appropriated at Town Meeting in not enough and it should be \$400,000. The costs have gone up and MSBA wants us to go back to Town Meeting in May and ask for the rest. Mr. Hipp stated that the Town Manager has floated the possibility of the town paying for the entire project and bond it. He advised having two warrant articles. One asking for the remainder of the \$400,000 for MSBA and another for the town to do the project. Mr. Hipp said there are no final decisions at this point and the School Building Committee, the School Committee still needs to discuss and then Town Meeting could have final say. The next meeting is scheduled for February 25, 2020. Mr. Twombly asked to keep the School Committee posted.
- The Clean Energy Task Force met yesterday. The Memorial School Green Team wants to show the movie "The Human Effect" in May. The team and advisor Joanna Frazier, Memorial School science teacher also want to come to a School Committee meeting around that time to present.
