1.0 Call to Order

2.2 Update on Corona Virus

Ms. Kuehn stated that no guidelines have come out from the Governor or DESE yet. She said there is a District-wide Back to School Working Group along with building level working groups. She said final guidelines will be out in July. She is also looking at feedback on the remote learning survey and teachers are taking advantage of professional development to prep for fall.

2.3 MABA Update

Mr. DeGennaro told the Committee he had a call with MSBA and the Town Manager in June. He said Mr. Lemnios did most of the talking and asked about next steps. We were told we need to send a letter stating we are removing our application. Following receipt of letter we will be removed from the MSBA process. After that we will go through a removal certification process. Mr. DeGennaro said he was starting the bid process for 3 projects that the town will be bonding for at Memorial School, which are window envelope, brick work and HVAC on roof.

2.4 Central Office Reorganization

Ms. Kuehn stated that with the shift of her becoming Superintendent it created other necessary steps that will affect the Central Office. She said she will continue to do professional development, curriculum and public records requests. There is now a need to hire a Director of Student Services. There is also a need for David DeGennaro to become Assistant Superintendent of Finance and Facilities, because he will have to take over other responsibilities. To do all these moves there is a need to reduce a staff member to half time.
