2.1 Information update on Charting the Course Together to Re-Open School Joyce Sullivan, Hull Director of Public Health, discussed the metric and how she tracks COVID cases. Ms. Sullivan answered questions from School Committee members. Ms. Kuehn thanked Ms. Sullivan. Ms. Kuehn also took the time to thank a lot of people by name, including the educators, leadership team, custodians, technology, central office staff, nurses, HTA copresidents and parents. Ms. Kuehn informed the Committee that students who have opted out for remote learning will be enrolled in Pirate Academy. Dr. Merrigan is the K-8 coordinator and Ms. Nosek and Ms. Grosso will coordinate at Hull High School. Pirate Academy is a one term or trimester commitment, with a two week notice they will be welcome to join whatever model we are in at that time. There have been and will have forum for parents. Grade 6 orientation and videos. We are working on bus routes and classroom procedures. Teachers will come to school at 8:00 am on Monday, August 31<sup>st</sup>. Currently there are 55 students at Jacobs signed up for remote, 33 at Memorial and 35 at Hull High. We usually have 10 homeschoolers but at this time we have 27 homeschoolers.
