# 5.2 COVID-19 Updates

Governor's Travel Order – reminder with holidays approaching

Ms. Kuehn reminded the community of the Governor's Travel Order, which applies to all visitors entering Massachusetts, including returning residents, who do not meet an exemption. The travel order states that these people are required to complete the Massachusetts Travel Form prior to arrival and quarantine for 14 days or produce a negative COVID-19 test result that has been administered up to 72-hours prior to your arrival in Massachusetts. If your COVID-19 test result has not been received prior to arrival, visitors and residents must quarantine until they receive a negative test result. Failure to comply may result in a \$500 fine per day.

Ms. Kuehn also reminded the community of the limit for indoor gatherings to 10 people and outdoor gatherings to 25 people and to be careful during the holidays.

# **Snow Days**

Ms. Kuehn stated the Commissioner has determined that for this school year only (2020-2021), if there are days when schools must close because of inclement weather or other emergency, districts may choose whether to treat those days as "snow days" to be made up later or provide all students with remote learning on those days in a manner that is consistent with the regulatory requirements and the decision will be made at the local level. If it is decided we do remote learning on any day we would use the Remote Wednesday model in each school. The middle school and high school use synchronous learning, while the elementary school uses synchronous and asynchronous learning. Ms. Kuehn said she is planning on taking each storm as an individual situation after consultation with the Fire Chief and DPW.

# Update on DPH Health Metrics

Ms. Kuehn said she is in ongoing communication with the Board of Health Nurses and the three school nurses, looking at transmission and the metrics. She said that if the BOH recommends going remote in a building or buildings we would do that. She also pointed out the new DPH Health Metrics chart, which is more in line with the number of community members that reside in

Hull and is glad the state refined the guidance.

## **Prioritizing In-person Learning**

The Commissioner is prioritizing in-person learning and the Hull Leadership team agrees. Ms. Kuehn said the team wants to prioritize but still want 6 feet of social distancing in the classrooms. She said they agree that all special educations students in all programs, including TBL, WAVES, TIDES, etc. should come in 4 days a week. She added the Engagement Committee 6-12 is looking into students who are not engaging and will be reaching out to those families for some inperson learning on the days they are normally at home and disengaged. We will invite them in to give them strategies to help engagement. Ms. Kuehn said she has also been talking to Mr. Hrivnak, Memorial School principal and Ms. Nosek, Hull High School principal, about trying to get a whole grade level back 4 days a week in each building, but not sure if space allows. Dr. Merrigan, Instructional Coach/Out-of-district Coordinator, updated the Committee on Pirate Academy, saying there are 23 students returning to in-person learning and it is a solid transition. There was a parent forum with school nurses. Memorial students started back today and the Pirate Academy teachers spoke with the school based teachers to make for a smooth transition. The Jacobs students won't return until December but will work with their in-school class on remote Wednesdays. Parents will do a walk thru for returning students. Ms. Peters said she is struggling with bringing back only one grad level per school. She said she was a little concerned at the Memorial School and would move to have more students back. Getting the middle school back would be great for our district. Ms. Kuehn said we are having those discussions too but we had extra teachers at the Jacobs School. She said she and Mr. Hrivnak have been working together, it is complex but they are on the same page. Mr. DeGennaro and Mr. Hrivnak have been working to on moving furniture because when you bring back these students we still want to be 6 feet apart so we are trying to make sure we monitor virus counts.

#### Winter Sports

Ms. Kuehn said she is waiting for MIAA guidelines on hockey and basketball so no registration has been sent out. We currently are not allowing people, not part of the school community, to enter the buildings now so I can't see how we would allow visiting teams with coaches and officials to enter the building. She said she would know more next Monday.

# 5.3 Memorandum of Agreement with School Secretaries

Ms. Kuehn asked the Committee to vote on the Secretaries receiving a one year contract with no language changes and a 1.5% COLA plus \$200 for COVID. Ms. Fleming said that technically she and Mr. Twombly were the School Committee members on the subcommittee but Ms. Kuehn did all the work.
