April 19, there is a survey to staff, there will be a focus group for students and there should be someone in place in May to transition quickly while the current principal and assistant principal are still here to stabilize the building. She said they would then run a search for assistant and possibly use an interim candidate. She said it is an exciting opportunity, and although we will miss Ms. Nosek and Mr. Mastrogiacomo, we see it as positive and we will move forward. Mr. Twombly asked if the assistant principal position could be advertised at the same time to attract someone to come now. Ms. Kuehn said it will be posted later this week. Mr. Twombly also commented that Ms. Nosek has done a fantastic job and Mr. Mastrogiacomo has very good presentation skills. He said they have been super to work with and they will be missed. Ms. Kuehn said we have a strong staff here and will move forward and take care of our students.

7.2 School Choice

Ms. Kuehn said that she recommends that we do not have school choice. She said once you open up a grade or grades you can't exclude anyone for school choice and you also can't look at the records of the students, which could run the risk of costing the district more money. Committee members agreed that this is not a good time for school choice.
