7.2 Opening of Schools by Building

Ms. Kuehn introduced the leadership team. Mr. Kyle Shaw, Jacobs School Principal; Mr. Anthony Hrivnak, Memorial School Principal; Mr. Michael Knybel, Hull High School Principal; and Ms. Christine Cappadona, Director of Curriculum and Assessment; gave updates of the first week of school in each building. They each said that it is exciting to have the buildings back to "normal" and the students fully participating in activities they enjoyed before COVID.

7.3 Athletics Update

Mr. Connor Duhaime, Athletic Director and Lexi Watkins, Athletic Trainer updated the Committee on the start of the fall season, stating that last week every team won. He talked about the energy people wanting to come here and play on the relatively new field and walk the track. He said 18 students are signed up for youth track, which just started and the Esports program is starting up. Mr. Duhaime also stated that he received two cameras so he can livestream anything on the field and in the gym. Ms. Watkins added that they are working on having AED mounted outside. Committee members asked questions and comments.

7.4 Best Educational Use of School Facilities

Ms. Kuehn rehashed the process we went thru with the Best Educational Use of School Facilities and how the MARS Group and the Ad Hoc Committee came to the same recommendation of option #4. Ms. Peters stated that the School Committee discussed it briefly at the summer retreat and in the short-term they agree on option #4 prek-7 at Jacobs and 8-12 at Hull High School. She said, it was determined that they would keep this item on the agenda and send emails to School Committee members and Ms. Kuehn and Ms. Saniuk can put them together and answer them. She said there is also a letter that needs to go to MSBA and she asked Ms. Kuehn to reach out to Joan Meschino. Ms. Peters stated that they will take steps not giant leaps for a year. Committee members discussed the need to move forward and take a formal vote. There was also a short discussion regarding an MOA or contract with the town.
