Call to Order

The meeting was called to order by Mr. Devine, Superintendent at 7:01 p.m. at Hull High School Second Floor Exhibition Room, 180 Main Street with the Salute to the Flag.

6.0 Superintendent's Business Items

6.1 Reorganization

Mr. Devine opened nominations for chair. Mr. Hipp nominated Ms. Stephanie Peters for chair, stating that, while he greatly enjoyed being the chair, he thought Ms. Peters has the knowledge and commitment to the schools and was chair in the past and did a good job.

Ms. Peters thanked School Committee members for the nomination and welcomed new member, Lucas Patenaude.

Mr. Hipp nominated Mr. David Twombly as Vice Chair, stating that Mr. Twombly has been both chair and vice chair in the past.

Mr. Devine stated that the Memorial School was placed in lockdown this morning out of an abundance of caution. The police arrived in moments and the situation was handled properly. Once it was over the students went back to class as normal.

#### 6.2 Out-of-State Field Trip

Mr. Hrivnak said this field trip is the eighth grade annual trip to Canobie Lake Park, which ties directly into the science curriculum.

#### 6.3 School Choice

Each year, prior to June 1<sup>st</sup>, school districts must vote on whether or not to participate in school choice. Mr. Devine said that he did not think school choice makes sense for the Hull Public Schools at this time and recommended not participating. Mr. Devine said that the amount of money coming to Hull is \$5,000 per student unless the student has special educational needs; the money would increase but not enough to cover the costs. He said there are a few south shore towns that participate in limited grades but none are located near Hull. He added that there would be the potential that if we go then other towns could follow suit, which could hurt our enrollment even more. People pass thru other towns on their way to work but no one passes thru Hull. Also, if we allow school choice now and then vote no in a few years, the kids that are already here are able to stay until graduation or if special education, until they turn 22 years old.

School Committee members also discussed their concerns at this time.

#### 8.0 School Committee Policy Issues – Policies ADB/GBC and IJNDC

Mr. Hrivnak informed the Committee that the Technology Committee met frequently this year and spoke to town council and a school attorney to update the technology policies to reflect current practices and procedures. He stated that policy ADB – Town of Hull Internet and Other technology Resources Acceptable Use Policy and Acknowledgement had very simple updates. Policy IJNDC – Mobile Computing Device Acceptable use Policy had a few more changes that included adding more to the introduction and to student responsibilities. Also adding a new section related to online educational services.
